9. Formation of Committee for Honorary Fellowship, ISRMTT Awards and Best Paper Awards.

A committee under the chairmanship of Dr. Gopal Dhawan was formed for ISRMTT awards in 41st meeting of Executive Committee meeting held on 26/04/2011. However, due to his busy schedule, it was deliberated again in the 42nd meeting of EC and it was decided to form a committee under the chairmanship of Sh. S.B. Suri to felicitate pioneers in the field of Rock Mechanics during the INDOROCK-2011. The committee discussed and decided the names for awards under the existing categories of i) Lifetime Achievement Award, ii) Outstanding contribution to Rock Mechanics for the year 2006, 2007, 2008, 2009 and 2010 and the Best Paper Award under the existing following categories:

- i) Case History of Tunnelling
- ii) Case History of Foundations on Rock
- iii) CAD/Software Packages
- iv) Application of Rock Mechanics in Hill Development
- v) Underground Space Technology
- vi) Rock testing and Monitoring of Rock Structures
- vii) Rock Blasting and Rock Dynamics.

The committee will screen the papers published in JRMTT and conferences/seminars for selection of best paper award for the period from 2006 to 2010.

10. Any other point with the permission of the Chair.

The Executive committee was apprised about the letter of concern by Director (CSMRS) written to The President (ISRMTT) regarding the organization of training course. A reply by the President was put up before the committee and the EC approves the contents of the reply and suggested to forward the same to Director (CSMRS).
