6. Activation of PAN

It was apprised that PAN allotted to ISRMTT was in inactivation mode because of some problem. The task of correction and reactivation was assigned to Sh. V.K. Khullar & Associates. The same has been got corrected and reactivated for which the agency has raised a bill of RS. 5000/- which was approved by the committee. The new PAN of ISRMTT is AAAAI0075L in place of the old PAN AAAAU0075L. State Bank of India has been intimated regarding the new PAN and requested to use the new PAN in all future accounts and also to transfer the TDS already deducted against the old PAN.

7. Auditing of Accounts for 2009-10, 2010-11 and 2011-12

It was apprised that ISRMTT's accounts for the year 2009-10 and 2010-11 has been completed. In fact the up-to date accounts till March 2012 have also been completed. The auditors have been requested to file the Income tax return. Chalan for the income tax return for Assessment Year 2011-12 has been generated for ₹ 34780/- and the same has been deposited in SBI.

8. Approval of Accountancy fee, audit fee and fee for activation of PAN

The accounting agency M/s V.K. Khullar and Associates has raised the accountancy charges from ₹ 12,000/- to ₹ 18,000/- and auditor's fee from ₹ 6,500/- to ₹ 7,500/-. Executive committee gave its approval for raised fee. Executive committee accorded approval for the payment of Accountancy charges ₹ 36,000 (2009-10 and 2010-11), ₹ 15,000/- towards audit fee (2009-10 and 2010-11) and ₹ 5,000/- towards fee for activation of PAN to the auditors.

9. Fixed deposits in Bank

It was apprised that new fixed deposits have been opened in the bank transferring the money from saving bank account. ISRMTT is having a total amount of Rs. 17,76,412/- as fixed deposits in State Bank of India in 9 accounts.

10. Presentation of ISRMTT Awards during INDOROCK 2011

For long pending ISRMTT awards, a committee under the Chairmanship of Shri S.B. Suri was formed for selection of pioneers in the field of Rock Mechanics and awards for best papers published in JRMTT. The awards were presented to the eminent personalities and the authors of the best paper awards on the basis of recommendation of the Awards Committee. The details of awards is as follows:
